2. Confirmation will be emailed back and then a payment can be made R150 / adult
3. A floor plan will be emailed back in the week before the market to show where you will be positioned

Terms and Conditions

- Stall holders are required to be at the bakery to set up by 8:30
- Stalls are allocated on a first come first serve basis and Two trees reserves the right to allocate stalls where they deem fit within the property
- R150-00 stall fees are payable 48 hrs after email confirmation has been sent please**
- Management can restrict the right of trade, or limit the type of merchandise to be sold
- All stall holders are subject to the normal rules and regulation of the bakery
- Stall holders are not guaranteed the same space at each monthly market
- No stallholders will be able to trade without filling in the relevant stallholder forms, which will be emailed for confirmation of acceptance
- There is a limit of one stall per stall holder
- No telephone bookings will be accepted
- Sub letting of stalls is not permitted
- Stalls will not be allocated to a person or religious organisation wishing to promote political or religious activities, collection of money, signatures or demonstrations

12. Loud speakers / hailers are not permitted at the market
13. Stallholders are requested to keep their areas clean and tidy at all times. Plastic refuse bins will be placed for any rubbish that needs to be discarded
14. Managements reserves the right to change any of the terms and conditions at its own discretion
15. Stall holders are only permitted to sell items of merchandise listed on the booking form and which have been approved my management
16. Should a stall holders not be able to make the day, Two Trees reserves the right to not refund the up front payment R150-00
17. In the event of rain or any other fair reason, R150 fee is non refundable.
18. Stall holders must stay in the demarcated area allocated to the stall for the day
19. Two Trees will not permit any stallholder to sell fake, illegal or fraudulent items on the Two Trees property. Should you not adhere to this regulation, Two Trees reserves the right to remove said fake, illegal or fraudulent items from the property. These items could lead to serious repercussions for yourselves and the responsibility will not rest of the management or staff of the bakery
20. No permanent fixtures will be allowed. Should the stall holder decide to move stalls, or cease trade, no claim for losses, damages or expenses arising from the moving of any fixtures may be made thereto from the Two Trees Bakery
21. Management reserves the right to close the flea market at its discretion if, in its opinion, circumstances demand.
22. Acceptance of receipt on payment of fees will serve as an agreement of the rules and regulations as set out above
23. Two Trees cannot guarantee electricity for the day. It is preferable that electricity is not required to trade
24. Stall holders to bring their own Gazebo and tables and chairs
25. No animals are permitted onto the property except in the event that it is pre arranged with management and is to the benefit of the public visiting the market.
